Amendment VC138: Guidelines for the Removal, Destruction or Lopping of Native Vegetation

Important amendments to Victoria's *Native vegetation clearing regulations*, the Victorian Planning Provisions (VPP) and all Victorian planning schemes came into effect on 12 December 2017. The changes improve protections of sensitive vegetation, tighten native vegetation offset requirements, and increase the role of site assessed information, monitoring and reporting.

In this industry briefing we hear from key government officials and industry leaders closely involved in the review and implementation of the amendments. Attendance is invaluable for those involved in the planning, preparation and/or assessment of applications to remove, destroy or lop native vegetation across Victoria (outside the Biodiversity Conservation Strategy / growth areas).
